Emissions reduction targets

In order to continue our progress to achieving Net Zero, we have adopted the following carbon reduction targets.

We will gradually purchase electric powered vehicles which will reduce our carbon footprint significantly. We will also reduce the amount of packaging used on products and deliveries. We also plan to reduce the amount of mileage in our vehicles.

We project that our carbon emissions will decrease over the next five years to **30 tCO₂e** by **2030**. This is a reduction of **25%**

Completed Carbon Reduction Initiatives

The following environmental management measures and projects have been completed or implemented since the **2021** baseline. The carbon emission reduction achieved by these schemes equate to **2.2 tCO₂e**, a **5.3%** reduction against the **2022** baseline and the measures will be in effect when performing the contract

We have reduced the amount of packaging on products and deliveries which has resulted in a reduction in our emissions.

In the future we hope to implement further measures such as:

Reducing the amount of vehicle mileage.

Purchasing electric vehicles.

Further reductions in packaging.
